#### **Welcome and Introductions**

Attendees introduced themselves. Tomevi introduced the new draft logo developed by Dain Erickon for the Little Fork River Watershed.

#### **1W1P Overview & Orientation**

Tomevi provided an overview of the planning process including watershed boundaries, planning timeline, budget, and committees. Tomevi noted that this is a voluntary plan and does not impact local laws or ordinances.

  - o Professional and community topic experts
  - Provide technical input and local perspective
  - Collaborate to identify:
    - Resource issues and concerns in the watershed
    - Action strategies to address resource concerns
    - Measureable goals to track progress

Budget reviewed: \$250,800.00 total (details on file). Tomevi reported that 50% of the grant has been received and the funds have been transferred to a separate bank account (Border Bank, International Falls) for tracking as recommended by Peterson Company.

A format for partners to bill eligible activities to the planning grant using sub agreements was discussed. A collective decision was made for Koochiching SWCD to develop sub agreements for each partner. Tomevi will work with Provinzino to draft a template.

## **Policy Committee Bylaws**

The group discussed details of the bylaws as presented and offered the following revision:

**ARTICLE VIII: MEETING LOCATION** 

- 1. Regular meetings of the Policy Committee will be held at a location within the Little Fork River or Big Fork River watersheds.

The Policy Committee will move forward without a Vice-Chair at this time and will reconsider at the next Policy Committee meeting.
